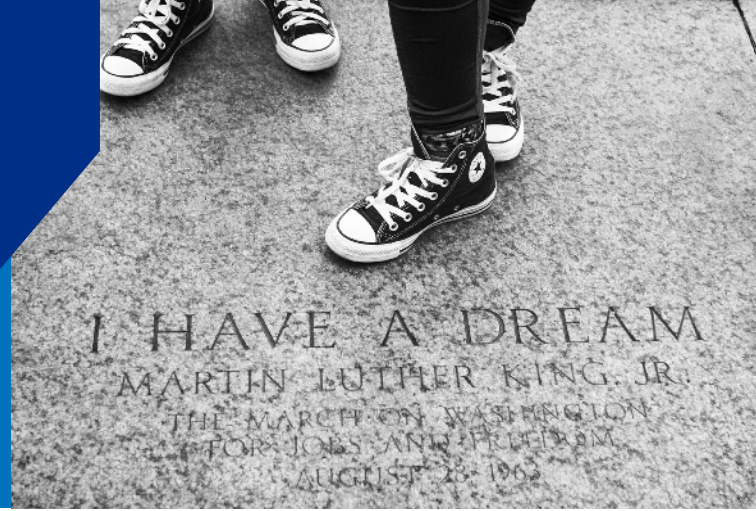


Hope, Belonging, and Opportunity
